Education Report

Questions for TUSD Superintendent George Mannon:

What's new in the TUSD? We continue to be concerned about the Governor's proposal to connect "flat funding" to his proposed November initiative. As you know, we sent out an eblast explaining that if the initiative fails to make the ballot or if the voters fail to approve it, then TUSD would be reduced \$10,000,000 on January 1, 2013. Although we have built reserves so that we could make it through '12-13 with that large reduction, '13-14 will be a problem for us. How are Torrance schools faring on the funding from No Child Left Behind--or what's left of it? NCLB was suppose to be amended or changed by 2008. We are now in 2012 with the political battle in Washington raging on, which creates grid lock in Congress. As you know the lofty goal of 100% of the students proficient by 2014 could never be met and now school districts and schools are seeing Program Improvement sanctions, which require prescriptive use of the funds. This is a real problem throughout the nation. Secretary Duncan has estimated that if the law is not changed, then by 2014, 86% of all the schools in the nation will

be in Program Improvement status. This is ridiculous!

The Language Of Democracy

Registrar-Recorder/County Clerk Dean Logan submitted a report to the County Board of Supervisors identifying five new languages that the Department will support as part of its election services. According to the report, Los Angeles County voters will now have access to translated election information in Hindi, Khmer, and Thai. In addition, where a local need is determined, the Department will provide language assistance in the form of bilingual pollworkers in Bengali and Gujarati. This brings the total languages supported by the County to 12 (including English). This now makes Los Angeles County the most linguistically diverse jurisdiction in the nation.



DRIVING DIRECTIONS TO PICKWICK GARDENS 1001 W. RIVERSIDE DR., BURBANK

- I-5 From the SOUTH After passing the merger of the 134 into I-5 (in Glendale) move immediately to the right lane and exit via the Western Ave. off ramp going west. At the bottom of the ramp, turn right on Western and go to Riverside Dr. and turn right. From there it is ½ mile to the front of Pickwick but do not park in front. Go on 1/10 mile around a curve on Riverside Dr. and turn into Pickwick's long driveway past the Ice Rink into their large parking lot at the back near the Garden entry and sales office.
- 1-5 From the NORTH... Exit Western Ave in Glendale, using the west off ramp, and turn right onto Western. Proceed to Riverside Dr. and turn right. See directions above.
- 134 From the EAST... When passing through Glendale move right into the lane with the I-5 Bakersfield sign. Immediately after the merger into I-5, take the Western Ave. (west ramp) and turn right at the bottom onto Western Ave. Go to Riverside Dr. and turn right. See directions above under I-5.
- 101 & 134 From the West Take the Hollywood freeway (101) east onto the Ventura (134 East) and exit at Buena Vista off ramp in Burbank. Turn right at the bottom at the signal and then turn on to Riverside Dr. Pickwick is about 1.5 miles on your left, just past Mariposa Ave. Take Pickwick's first drive on the left, past the ice rink entry and park at the back near the garden entry, passing the entrance to ice skating and park at the back near the garden walkway.

Top Two Primary System

There are actually two primary elections taking place on June 5, 2012: a) the Presidential Primary, which is a partisan party nomination process used to select candidates for President and county central committees and b) the statewide Top Two Primary elections for congressional and state elective offices. The Presidential Primary produces "party-nominated candidates" for president who then appear on the November General Election ballot by party. This is the type of primary that California voters are used to. The Top Two primary system, however, produces two "voter-nominated candidates" who have received the two highest vote counts and who then advance to the November General Election. Even if one of the candidates receives more than 50 percent of the votes, there is still a "runoff" between the top two vote getters. With the Top Two Primary system, all candidates running for an office are listed on one ballot, regardless of their party preference. All voters may vote for any candidate in the list.

Here are some of the special features of balloting in the Top Two system that need to be understood by the voters:

- The Top Two system was placed on the June 2010 ballot by the legislature as a result of state budget negotiations and was passed by the voters.
- Voters will not see a "straight party ticket" on the ballot, but rather a list of names for the different contests with each candidate's party preference indicated. However, a candidate for a voter-nominated office may choose not to have his or her party preference—as disclosed on their most recent affidavit of registration indicated on the ballot. It is possible for two voter-nominated candidates with the same party affiliation to appear on the November ballot.
- Political parties may endorse candidates in the Top Two primary. Sample ballots must include a section listing these party endorsements.
- Although votes may be cast for write-in candidates in the Top Two primary election, no write-in votes are allowed in the November general election for the Top Two contests.

As of this writing, there are court challenges to the Top Two Primary system currently pending,

based on the ban on write-in votes in the General Election for Top Two offices and on constitutional issues of third party access to the ballot and voters' right of choice.



Topic for discussion will the relationship of state government to metropolitan government. A bird's eye view of the year long state league study in this field with be presented under the chairmanship of Mrs. Donald Brink.

featured, according to Mrs. Lee Bower, program chairman. Purpose of the orientation is to familiarize new members with the function of unit meetings and the relationship of the individual member with the total league role.
